What is a Dealer's License

The Dealer's License is needed before any part or product of any wildlife, includes processed/or dressed meat and by-products, is sold. This may refer to persons who hunt wildlife to sell to businesses or businesses that sell to the general public.

What is needed to apply for a Dealer's License?

- ✓ A completed application form submitted to the Forest Department.
- ✓ Copy of Social Security card or Passport.
- Payment for the License that you are applying for.

Regulations

- Wildlife should not be bought or sold during the closed seasons for the specified wildlife.
- Young or immature wildlife should not be bought or sold
- Any person with a Dealer's License needs to acquire the wildlife part from a person with a valid Hunting License.
