Non-Belizean Annual Hunting License	Non-Belizeans to carry out hunting activities for 1 year.	\$500.00 BZ		

What if I want to sell the meat?

Any wildlife caught under this license is to be used for personal use only. If a person who is possession of a hunting license is interested in selling wildlife caught, the person has to apply for a **Dealer's** License.

What is needed to apply for a hunting license?

- Valid gun license issued by the Police Department.
- A completed application form submitted to the Forest Department.
- ✓ Copy of Social Security card or Passport.
- Payment for the License that you are applying for.

Regulations for Hunting

•	The use of any artificial light to facilitate the shooting of any animal is prohibited. The use in hunting of any substance locally known as " Fish Poison " is prohibited.	•	Hunting in the Mountain Pine Ridge Forest Reserve, Chiquibul Forest Reserve, Chiquibul National Park, Crooked Tree Wildlife Sanctuary, Cockscomb Basin Wildlife Sanctuary and other areas under the National Park System Act are prohibited.
•	The SELLING OR EXPORTING of any animal dead or alive, hunted under this license is prohibited without the proper permits.	•	Hunting is only allowed in the district in which the license holder resides.
•	Hunting Licenses are not transferable .	•	Hunting of immature wildlife or females with young is prohibited.
•	The hunting license does not entitle the holder to shoot Jaguars, Pumas, Margays, Ocelots or Jaguarundi. Neither does it provide for the hunting of other animals such as crocodiles, tapirs, manatees, monkeys, coatimundi, raccoons, anteaters, kinkajou or any species of parrots in Belize.	•	The license holder cannot kill more than 1 game species per hunting trip. The license holder can only hunt wildlife during their specified open season.
